

# Society for Benefit-Cost Analysis

## Author Permission to Post

\_\_\_\_\_ (“Author”) is the owner of all rights to certain textual material consisting of presentation materials and/or working papers as more specifically identified below (“Author’s Work”).

The University of Washington’s Evans School of Public Affairs (“the University”) operates the Society for Benefit-Cost Analysis (“the Society”) website (“the Website”), through which the Society makes available for electronic downloading papers and presentations to viewers for their free use and redistribution.

### **2. Publication and Redistribution, Release**

Author understands and agrees that Author’s Work, if posted on the Website, will be made available for free electronic downloading and redistribution on a worldwide basis to all persons with access to the Website. Author further understands and agrees that neither the Society nor the University are under any obligation to publish Author’s Work submitted herewith on the Website. Author hereby releases, for him/her self and his/her heirs and assigns, the Society and University of Washington and their officers, employees and agents from all claims or causes of action (including but not limited to any claim of copyright infringement), known or unknown, arising out of or in any way related to the submission of the Author’s Work, the Society or University’s acceptance of Author’s Work, or the Society or University’s use of the Author’s Work in accordance with the permission granted herein, including but not limited to the publication and redistribution of the Author’s Work on the Website. The Society and University retain the right to remove Author’s Work from the Website at their discretion.

### **3. Retained Rights**

Author retains the right to submit Author’s Work to other publications and otherwise use the Author’s Work. Author understands and agrees, however, that the permission granted herein and the University’s right to post and distribute Author’s Work as set forth herein may not be revoked.

### **4. Transferability**

Author agrees that the Society or University may transfer their rights to Author’s Work under this agreement to another entity that would maintain the Website.

## 5. Formatting and Editing

Formatting may be applied to Author's Work if it is accepted by the Website for publication, and that Author's Work may be edited for grammatical correctness and for conformity to Society or University stylistic standards prior to actual posting on the Website.

### Author's Warranties

Author represents and warrants that Author owns all rights in the Author's Work and that Author has not previously assigned or transferred any such rights to another party in a manner that is inconsistent with the terms of the permission granted herein. Author further warrants that the Author's Work is the Author's original work and that the publication of the Author's Work will not infringe on any copyright or any other right of any other party, nor defame or violate the right of privacy or any other right of any other party. Author shall indemnify and hold the Society and the University of Washington and their officers, employees and agents harmless from and against any damages, cost or liability, including reasonable attorney's fees, arising from any claims or causes of action brought by any third party for copyright infringement or the violation of any proprietary or other right of any other party, including but not limited to any claims of defamation or violation of the right of privacy, in connection with the Society's or University's use or publication of Author's Work.
